
Coronavirus (COVID-19) Information and Bay Area Shelter-in-Place Order

Where to Access Hygiene Services

As per the Santa Clara County Public Health Department Order, the City has closed all park buildings, restrooms and playground areas to slow the spread of COVID-19. The City and nonprofit MOVE, provide handwashing stations, fixed or portable restrooms, drinking water and garbage service for all safe parking lots. In addition, the City has temporary restroom and/or hand wash stations at the following locations:

- Two portable restrooms and hand wash stations are already available at Rengstorff Park
- One temporary portable restroom and hand wash station will be available at Eagle Park by Saturday, March 21
- Temporary hand-wash hygiene stations will also be available at the City Hall, Library, MVCPA and Centennial Plaza (Mountain View Transit Center) by Saturday, March 21

What about Parking Enforcement During the Bay Area Shelter-in-Place Order?

We highly encourage you to enroll in the Safe Parking Program for access hygiene services during this COVID-19 pandemic. However, the MVPD has temporarily suspended proactive parking enforcement efforts, including 72-hour violations, to encourage compliance with the shelter-in-place directive and out of sensitivity to the impacts these requirements are having on our vulnerable community. At this time, officers will only conduct parking enforcement if we receive complaints regarding a public health or a public safety hazard.

Is Safe Parking Still Available?

We encourage you to enroll in the Safe Parking program. As of March 20, there is no wait list for oversized vehicles. As soon as you are enrolled with the CSA, you will be able to use a space at one of our designated Safe Parking lots. Hygiene and other services are being provided on the lots for participants.
