LEADERSHIP

Why are you running for this position?

I am running to address the major challenges facing Mountain View. My top priority is the crisis in housing affordability, which threatens to displace many working families and prevents many more from calling Mountain View "home." Severe traffic congestion negatively impacts the quality of life for residents and commuters alike. I also want to work to increase the confidence and trust of the public in government by ensuring that residents have access to timely information and ample opportunity to provide input on crucial issues.

What distinguishes you from the other candidates?

I have the most comprehensive position on housing. I believe that I am the only candidate who supports short-term solutions to address the housing crisis and displacement, including rent relief and tenant protections. When the council discussed possible protections in March 2016, I supported the binding arbitration provision that the council ultimately rejected. I will be voting "yes" on the ballot initiative backed by the Mountain View Tenants Coalition.

I also strongly support building more housing in Mountain View, both market rate and especially below market rate housing for working families. I support inclusionary zoning and other policies that will increase affordable housing stock, and I support measures that will make it easier to build housing generally.

If elected to office what will be among your top legislative priorities? Specify goals.

- 1. Housing affordability and displacement prevention implement solutions that address the problems comprehensively:
 - a. The root of the problem is the regional jobs/housing imbalance. The long-term solution is to address this problem through land use planning that prioritizes housing over office development. Job growth increases the demand for housing, and when supply is limited, housing costs skyrocket.
 - b. In the medium-term, promote policies that increase affordable (below market rate) housing. I support inclusionary zoning (including rental housing if and when Palmer is fixed) and impact fees on new development, especially office space, to increase funding for affordable housing.
 - c. Support short-term anti-displacement policies and tenant protections that help working families stay in their homes. I support relocation assistance for displaced tenants and rapid rehousing policies to prevent homelessness.
- 2. Traffic congestion and safety:
 - a. Implement and enforce strong transportation demand management policies with aggressive "mode shift" goals (reducing the number of people who drive alone and increasing use of alternative modes of transportation).
 - b. Invest in bicycle/pedestrian infrastructure, especially routes to schools and trails used by commuters.

- c. Support impact fees on new development to fund improvements to transportation infrastructure.
- 3. Expand opportunities for civic engagement and resident participation in critical decision-making:
 - a. Release council agendas earlier and encourage publication of agendas in the local newspaper (the Mountain View Voice).
 - b. Enhance noticing requirements to ensure that residents know about critical issues that will directly affect them.
 - c. Create an Open Data policy and portal, and make publicly available in machine-readable formats government data that would be valuable to the community.

1. Will you support the Opportunity to Work initiative in San Jose sponsored by labor, faith, and community groups? The measure will be on the

ballot in November and aims to reduce involuntary part-time work by requiring businesses to offer hours as they become available to current employees before hiring new staff. (See email attachment – OpportunityToWork) Yesx No Why? OTW is a reasonable and flexible law that allows workers to have an opportunity to get full-time work while maintaining the employer's ability to determine the nature of the work, the qualifications necessary, and the shifts. It is an important and progressive first-of-its-kind initiative that will help thousands of working families in San Jose, and, if it is successful, similar workers' rights may be adopted in other municipalities.
May we list your name publically as a supporter? Yes_x No Why? I helped gather signatures for the Opportunity to Work initiative and am proud to support it publicly.
2. Would you support a Living Wage policy for the City, like the living wage policy at Santa Clara County that would require the City and its contractors to pay wages that are sufficient to cover necessities and to provide essential benefits? (See email attachment – Living Wage) Yesx No Why? The cost of living in Santa Clara County, and especially in Mountain View, is extremely high. Without reasonable wages, working families will either need to make difficult choices like paying rent or putting food on the table, or they will need to endure unreasonable commutes.
3. Do you support efforts to promote local hiring through a requirement that developers use state certified apprentices on large construction projects? (see email attachment – Apprenticeships) Yesx No Why? I support policies that create apprenticeship opportunities and good entry-level jobs for our most underserved community members—homeless, veterans, women, at-risk youth, people of color, and formerly incarcerated individuals. Apprenticeships provide actual pathways into middle-class careers.
STANDARD OF LIVING FOR WORKING FAMILIES
4. (a) Do you support the contracting out of public services? Yes Nox Why? Contracting out of public services is most likely a cost-cutting measure at the expense of the workers. If there are circumstances under which contracting out is appropriate, then measures must be taken to ensure that workers are compensated fairly and provided decent benefits.
If yes, under what circumstances is contracting out appropriate?
(b) In the event any work was to be contracted out by a public agency to a private firm, would you support the requirement that contractors bid for the contract based on the prevailing wage and benefit rate? Yesx No Why? I think it is reasonable to require that prevailing wage and benefit rate be among the criteria used in evaluating bids. Contractors who provide prevailing wages are likely also to be generally reputable and responsible.

nature of the work is temporary, then in-sourcing could be achieved through the creation of limited-period positions instead of contracting. Jobs performed long-term should be transitioned to permanent positions.
5. (a) Do you support prevailing wage? Yesx No Why? Prevailing wage ensures that contractors don't underbid at the expense of laborers. This not only ensures that workers are fairly compensated, but also prevents cost overruns and fosters safer work conditions.
(b) Would you support the implementation of a Labor Compliance Program (LCP) to enforce the payment of prevailing wages in your county? Yesx No Why? If yes, would you lead this action? This is a reasonable preventive measure to combat wage theft. Prevailing wage requirements are worthless if there does not exist a mechanism to ensure that contractors are providing the mandated compensation to workers. I would be willing to lead this action.
6. Do you support requiring tax audits for employers who violate labor laws such as workers' compensation, unemployment insurance and the minimum wage?
Yesx No Why? Like the aforementioned LCP, this is an important measure that ensures fair wage protections for workers, and employer transparency and accountability.
7. Do you support a \$15/hour minimum wage for all workers with indexing by 2019?
Yesx No Why? This ensures that wages more closely align with the cost of living and keep up with inflation. Mountain View has already adopted a schedule to a \$15/hr minimum wage by 2018.
8. Do you support prohibiting employers from making workers sign away basic rights with mandatory arbitration agreements? Yesx_ No Why? I think regulations that protect workers' rights and prevent exploitive practices are reasonable.
9. Do you support requiring employers to provide predictable work schedules and give employees adequate notice of schedule changes? Yesx No Why? These are reasonable requirements provided that employers retain the flexibility to negotiate appropriate agreements with workers that allow for some degree of unpredictability when absolutely necessary in exchange for fair compensation for work performed under such circumstances.

What strategies will you advocate to in-source work, i.e., to return

previously outsourced work to the city government? The best opportunity would be to advocate for in-sourcing during the development of the fiscal budget. If outsourcing was in fact done as a cost-cutting measure, or if the

WORKERS' RIGHTS
11. Do you support the use of card check agreements as a way for workers to decide on choosing a union? Will you publicly support calling for card-check in National Legislation, i.e. The Employee Free Choice Act? Yesx No Why? I support the right to organize. Card check agreements ensure that there is no interference from entities hostile to organization in the form of captive audience meetings, intimidation, or harassment. I would support national legislation.
12. What is your understanding of the content and purpose of a card check/neutrality agreement? Do you support the use of such agreements as a way for workers to organize into a union with less delays and conflict?
The hotel operator (or other employer) guarantees employees the opportunity to organize without interference. In exchange, the workers agree not to strike, picket, boycott, or conduct a corporate campaign against the employer. Yes, I support such agreements.
13. When public funds become involved in a project (i.e. a hotel), do you support the use of neutrality agreements? Yesx No Why and how? Neutrality agreements help prevent labor disputes. My preference would be to adopt a policy requiring neutrality agreements as part of the RFP process and not negotiate project by project.
14. When a city has a financial investment in a development project (e.g. a hotel), do you support a requirement the project developer to sign a labor peace agreement that covers future operations to protect the city's financial interest?
Yes_x No Explain your answer briefly. A key objective in making such an investment is ensuring an appropriate return, and eliminating the possibility of labor disputes helps ensure that return. However, the right to organize also helps working families receive quality work and fair compensation.
15. Do you support a worker retention policy for the City – a policy that will provide basic job protections to ensure service workers (such as cafeteria workers and security guards) on office campuses do not lose their jobs when the service contractor changes or when contracted services are brought in-house? Yes_x_ No Explain your answer briefly. I think it is reasonable to provide basic protections to workers who might otherwise be at risk of losing their job when the service contractor changes or when services are brought in-house.
16. (a) Do you support final and binding arbitration in collective bargaining and negotiations for public safety employees who do not have the right to strike?

intended to bring a neutral third party to facilitate a fair process and a best faith effort to reach an agreement, Mountain View has a long history and commitment to negotiating fair contracts at the bargaining table. I want to continue the tradition of negotiating in good faith and ensuring fair and competitive compensation for public safety employees. I am currently uncomfortable introducing a third party into what has been a fair process with a good history. For the same reason, if there were a disagreement at the bargaining table, I would strongly oppose turning to the voters and imposing a contract by ballot initiative. This removes any incentive to negotiate in good faith.
(b) Do you believe that the City Charter provides for a binding arbitration process for public safety employees that is fair for all parties? Yes Nox Why? The Mountain View City Charter appears to be silent on binding arbitration.
(c) Do you support final and binding arbitration for grievances for public
employees? Yes Nox Why? I would favor a fair and reasonable internal process for resolving disputes that is mutually agreed to in negotiations. Non-binding alternative dispute resolution processes may be appropriate for certain grievances, but any process should be mutually acceptable to employee and employer. Historically, Mountain View has been able to resolve grievances for public employees absent binding arbitration.
17. Do you support agency shop for public workers? Yesx No Why? Non-union employees who derive the benefit of negotiated contracts should pay a fee to help cover the cost of collective bargaining.
18. Do you support the requirement that all employers be bound to the terms and conditions of an AFL-CIO Building Trades Council Project Labor Agreement on construction projects where government funds are involved? Yesx No Why? PLAs are an appropriate way to ensure quality work and that contractors follow the rules. They are a preventive measure to combat wage theft and violations of workers' rights. Additionally, they eliminate labor disputes because of built-in enforcement mechanisms.

POLICY FOR USE OF VENDORS

- 1. Union Venders: All affiliated AFL-CIO unions, friends of labor, and endorsed candidates/office holders will be expected to use union vendors when any services are paid and not donated, when union venders are available as determined by the Central Labor Council.
- 2. Boycotted Vendors: No AFL-CIO union, friend of labor, or C.O.P.E. endorsed candidates/office holders will be given authorization to use a vendor which appears on any authorized AFL-CIO "Do Not Patronize" list. Said boycott listing is to be considered as a perpetual picket of a vendor.
- 3. Donated Union Vendor Services: If union vendors donate any services, the South Bay Labor Council should be informed of such, prior to any utilization of such services.
- 4. Donated Non-Union Vendor Services: All AFL-CIO affiliates, friends of labor, or C.O.P.E. endorsed candidates/office holders are expected to contact the South Bay Labor Council to request permission to use "Labor Donated" non-union vendors. In most instances, requests for exemption must be made no less than thirty (30) days prior to the use of said services. If exemption is warranted, permission may be given only by the Business Manager/ designee of the South Bay Labor Council. Permission will only be given if evidence can be furnished to prove that the labor was in fact donated to the affected party. This provision is not to be interpreted as a requirement to give exemption in all cases nor that any exemption is automatic.
- 5. No Mandate To Require Services Not Planned: Nothing contained in this policy shall be construed as authorizing any union to require the use of a type of vendor service which was otherwise not contemplated by a party.

6. Penalty Imposed: Any AFL-CIO union, friend of labor, or C.O.P.E. endorsed candidate/office holder who does not follow the above policies may be subject to action by the Council including but not limited to censure and/or removal of any endorsement.
